Select the section you want to run your search across by ticking the box.



If you know the title of a specific book or journal, you can type it into the search bar to find it. But if you want to browse across the books and journals to find out what's available, you can do this too. Select Books & Journals under the Content tab in the Explore box, choose your content type, and then view an A-Z list of everything that's available.
